### 15 Description of Equipment or Protective System

The Wolflite XT-\*\* is a handlamp designed for use in Zone 1 or Zone 0 hazardous areas.

It comprises a Nylon based static dissipative body with a rubber 2<sup>nd</sup> shot that provides visual detail and protection against mechanical shocks. The front lens is constructed from either anti-static coated 4mm polycarbonate, or from 4mm glass. A switch underneath the handle contains a magnet that operates a reed switch mounted inside the handlamp body. A custom Lithium Ion battery pack provides power for the electronic control circuit and up to four LEDs.

The Wolflite XT-\*\* is designed to be charged in a safe area using the approved charger that has a maximum output voltage not exceeding 14V.

The 1<sup>st</sup> star is a number that denotes different sub models for operational purposes and does not affect the marking of the equipment. The 2<sup>nd</sup> star denotes versions with different codes:
